## MASONRY HEATER DESIGN/BUILD CONTEST 2012

### CONTEST RULES:

- 1.) The heater must have been built between the time period of March 1, 1980 – March 1, 2012.
- 2.) The heater may have been built for a customer or for yourself.
- 3.) A project that has been entered and won any place in a previous MHA contest may not be entered again.
- 4.) Contestants who win any place (1,2,3) may not enter in the same category the next year (skip a year), but may enter other categories.
- 5.) The contest is open to individuals and companies.
- 6.) An individual or company may enter up to three designs in this contest per year.
- 7.) This year we are switching to a three-ring notebook submission instead of posting photos on the wall and tables. The notebooks should include the following:
  - A. The official entry form..
  - B. A type-written page with a description of the scope of work and price of the project. Describe what the customer wanted to accomplish and how you met their needs. Include materials used. DO NOT include your company name or your name on this page.
  - B. Five to ten 5" x 7" to 8" x 10" size photos that show the project before, during, and after. We suggest that each page should be placed in a page protector to protect your photos (two pages placed front to back may be placed inside each page protector). No identifying marks, signs, or people may be in the photos.
- 8.) Photos **must also be submitted on a CD** in jpg format in high resolution (600 dpi or greater). The photos become the property of the MHA and contestant agrees to allow MHA to use the photos for any purpose, giving credit to the designer/builder.
- 9.) There will be three places awarded, with a trophy for each place. Judging will be done by professionals in the industry at the annual MHA meeting at Wildacres. Judges will be asked to score on a point system for aesthetics, skill in craftsmanship, and creative use of materials.
- 10.) The entry must meet guidelines as described by the MHA be classified as a functioning "Masonry Heater."
- 11.) Kits may be used for the interior core, but not the exterior finish work. Manufactured doors and other metal/cast/glass components may be used.
- 10.) Entries must be the original design of the contestant.
- 11.) All entry materials must be placed in a plain envelope and turned in to MHA Director, Richard Smith, by 3 pm. on the second day of the annual meeting at Wildacres. If mailing, be sure to allow time for your entry to arrive at least 7 days before the contest.
- 12.) Entrant must be a member in good standing of the MHA, but need not be present at the annual meeting.
- 13.) Fee is \$30.00 per entry and must be submitted with the entry.

If any of the above requirements are not met, the contestant's entry will be disqualified. No refund of fees.

## BAKE OVEN DESIGN/BUILD CONTEST 2012

### CONTEST RULES:

- 1.) The bake oven must have been built between the time period of March 1, 1980 – March 1, 2012.
- 2.) The bake oven may have been built for a customer or for yourself, commercial or residential.
- 3.) A project that has been entered and won any place in a previous MHA contest may not be entered again.
- 4.) Contestants who win any place may not enter in the same category until the second year (skip a year), but may enter other categories.
- 5.) The contest is open to individuals and companies.
- 6.) An individual or company may enter up to three designs in this contest.
- 7.) This year we are switching to a three-ring notebook submission instead of posting photos on the wall and tables. The notebooks should include the following:
  - A. The official entry form.
  - B. A type-written page with a description of the scope of work and price of the project. Describe what the customer wanted to accomplish and how you met their needs. Include materials used. **DO NOT** include your company name or your name on this page.
  - B. Five to ten 5" x 7" to 8" x 10" size photos that show the project before, during, and after. We suggest that each page should be placed in a page protector to protect your photos (two pages placed front to back may be placed inside each page protector). No identifying marks, signs, or people may be in the photos.
- 8.) Photos **must also be submitted on a CD** in jpg format in high resolution (300 dpi or greater). The photos become the property of the MHA and contestant agrees to allow MHA to use the photos for any purpose, giving credit to the designer/builder.
- 9.) There will be three places awarded, with a trophy for each place. Judging will be done by peers in the industry at the annual MHA meeting at Wildacres, and will be based on a point system.
- 10.) Kits may be used for the oven, but not for the exterior finish work. Manufactured doors and other metal/cast/glass components may be used.
- 11.) To classify as a bake oven, it must be primarily a bake oven but may have other features such as wood storage, bench, lighting, roof, cook stove or fireplace. The project may not be a part of a masonry heater (enter the masonry heater contest for that). The oven may be residential or commercial and be an indoor or outdoor oven.
- 10.) Entries must be the original design of the contestant.
- 11.) All entry materials must be placed in a plain envelope and turned in to MHA Director, Richard Smith, by 3 pm. on the second day of the annual meeting
- 12.) Entrant must be a member in good standing of the MHA but need not be present at the annual meeting.
- 13.) Fee is \$30.00 per entry and must be submitted with the entry or the entry will not be accepted.

If any of the above requirements are not met, the contestant's entry will be disqualified. No refunds of fees.

**Fireplaces, chimneys, barbecues, or other masonry projects**

**CONTEST RULES:**

- 1.) The project must have been built anytime from March 1, 1980 – March 1, 2011.
- 2.) The project may have been built for a customer or for yourself – residential only.
- 3.) A project that has been entered and won any place in a previous MHA contest may not be entered again.
- 4.) Contestants who win any place may not enter in the same category until the second year (skip a year), but may enter other categories.
- 5.) The contest is open to individuals and companies.
- 6.) An individual or company may enter up to three designs in each category.
- 7.) This year we are switching to a three-ring notebook submission instead of posting photos on the wall and tables. The notebooks should include the following:
  - A. The official entry form.
  - B. A type-written page with a description of the scope of work and price of the project. Describe what the customer wanted to accomplish and how you met their needs. Include materials used. **DO NOT** include your company name or your name on this page.
  - C. Five to ten 5" x 7" to 8" x 10" size photos that show the project before, during, and after. We suggest that each page should be placed in a page protector to protect your photos (two pages placed front to back may be placed inside each page protector). No identifying marks, signs, or people may be in the photos.
  - D. Photos **must also be submitted on a CD** in jpg format in high resolution (600 dpi or greater). The photos become the property of the MHA and contestant agrees to allow MHA to use the photos for any purpose, giving credit to the designer/builder.
- 8.) There will be three places awarded, with a trophy for each place. Judging will be done by professionals in the industry at the annual MHA meeting at Wildacres. Judges will be asked to score on a point system for aesthetics, skill in craftsmanship, and creative use of materials.
- 9.) Indoor and outdoor fireplaces, chimneys, cookstoves, barbecues, firepits, pillars, houses, outdoor rooms, or other masonry projects are eligible. If a bake oven or masonry heater is a part of the same project and is part of the design it may be included.
- 10.) Entries must be the original design of the contestant or company.
- 11.) All entry materials must be placed in a plain envelope and turned in to MHA Director, Richard Smith, by 3 pm. on the second day of the annual meeting.
- 12.) Entrant must be a member in good standing of the MHA but need not be present at the annual meeting.
- 13.) Fee is \$30.00 per entry and must be submitted with the entry or the entry will not be accepted.
- 14.) If any of the above requirements are not met, the contestant's entry will be disqualified. No refunds of fees.
